A specific budget shall be allocated for CSR activities and spending on CSR activities in accordance with Companies Act, 2013 and rules made there under. The CSR policy of the Company is in accordance with the Companies (Corporate Social Responsibility Policy) Amendment Rules, 2021. In case Company fails to spend such amount, the Board shall deposit such amount to a Fund specified in Schedule VII, within a period of six months of the expiry of the financial year.

The Board of Directors, Management and all the employees subscribe to the philosophy of compassionate care. We believe and act on an ethos of generosity and compassion, characterised by willingness to build a society that works for everyone. This is the cornerstone of our CSR policy. CSR Committee of Board of SELAN will review the policy from time to time based on the changing needs and aspirations of the target beneficiaries and make suitable modifications as may be necessary.
