महाराष्ट्र में ठाणे की विशेष अदालत ने दो बच्चियों से बलात्कार के दोषी 35 वर्षीय स्कूल वैन चालक को 10 साल कठोर कारावास की सजा सुनाई है। वह इन बच्चियों को स्कूल पहुंचाने और वहां से वापस लाने का काम करता था। दोषी ने जून से

दिसंबर 2016 के बीच दोनों बच्चियों से कई बार बलात्कार किया था।

विशेष पॉक्सो (यौन अपराधों से बाल संरक्षण) कानून अदालत के न्यायाधीश एसपी गोंडालेकर ने दोषी तुलसीराम मानेरे पर 28 हजार रुपए का जुर्माना भी लगाया है। लोक अभियोजक उज्वला मोहोल्कर ने बताया कि मानेरे बच्चियों को धमकी भी देता था।
